d) National Grid power line proposed route pre consultation – all members able too to attend the open day 23rd July.

271. Councillor Reports and Items raised.

- a) Following a report and recommendation from Cllr L Dinsdale on other local Village Hall user rates the hall rates are set at £10 for regular users/ £12 for one off events/ £30 Commercial rate (min 2 hrs). - b) The RoSPA report is reviewed and it resolved to remove the trim trail post and replace this and the damaged soft pour floor once funding has been found. - d) Following discussion on the merits of storing the tables and chairs in the large storeroom versus in the hall itself, it is resolved that these will be left stacked in the hall. It is determined not to purchase trolleys for the handling of the village hall chairs currently and to review the requirement at a later meeting.
